EMMA'S DANCE broke alertly in her bow, set the pace off the rail to the stretch then kicked away to mid stretch and was under steady urging to the line. SILVER LYRIC chased the winner early, got outkicked two wide to the stretch then finished willingly for second. SILK ROAD SALLY had no speed then circled four wide to the stretch but lacked a closing response. WINNING APPEAL was outsprinted to the turn then saved ground to no avail. REINA DE REYES pressed the winner three wide to the stretch, lugged inward sharply in mid stretch and cut off MOMMA MOCCA, took up to straighten out and weakened. MOMMA MOCCA had no speed, came two wide to the stretch, eased out in upper stretch then tried to split rivals nearing the furlong marker but was cut off by REINA DE REYES, steadied and weakened. LAWYER PROOF pressed the pace to the turn, was caught four wide to the stretch then tired. LADY SKYWALKER was chasing early, got outkicked on the turn and gave way in the stretch. The stewards conducted an inquiry into the stretch run involving REINA DE REYES and MOMMA MOCCA and disqualified REINA DE REYES from fifth to sixth for interference.
